ORDER

As per the letters read above Government have accorded sanction to IHRD for extending the benefit of Rule 60(C) of Part 1 of KSR to the teaching faculty of the educational institutions under IHRD, Subject to the conditions specified in the Rule 60 (C) of Part 1 KSR as detailed below

1. "The teaching staff of all educational institutions (including Principals of colleges) who complete the age of superannuation (58 years in the case of IHRD) during the course of an academic year shall continue still last day of the month in which academic year ends; but the extended period of service shall not be reckoned for any service benefits such as increment, higher grade, accrual of leave, promotion and pay revision effective from a date after the date of superannuation."

- 2. The teaching staff of educational institutions who are allowed to continue in service beyond the date of superannuation till the end of the academic year will not be eligible for any leave other than casual leave during the period of their service beyond the date of superannuation and if they apply for any leave other than casual leave during the period, they shall be retired from service from the date of such application of leave.
- 3. In the circumstances sanction is hereby accorded with immediate effect to all the teaching faculties in the educational institutions under IHRD to continue in service beyond the date of superannuation till the end of the academic year subject to the conditions stated in the preceding paragraphs.

ORDER

As per letters read 3rd above the Director, IHRD has submitted a proposal for unification of date of superannuation of teaching faculty members in the educational institutions under IHRD on par with Government Educational Institutions, with approval of Executive Committee and Governing Body of IHRD.

Government have examined the matter in detail. In educational institutions under LBS Centre for Science and Technology and Cooperative Academy of Professional Education (CAPE) teaching faculties are allowed to continue in service till the last day of academic year. In the circumstances, Government are pleased to accord sanction for extending the benefit of Rule 60(C) of Part I, KSRs to the employees of IHRD, as the benefit is for the student's advantage, so as to avoid the hardship caused due to the retirement of teachers by the middle of the academic year and the time lapse evolved for the appointment of substitute teachers / guest faculties etc., subject to the conditions specified in the Rule 60(C) of Part I, KSRs as below.

(i) the teaching staff of all educational institutions (including Principals

of Colleges) who complete the age of 56 years during the course of an academic year shall continue till last day of the month in which academic year ends; but the extended period of service shall not be reckoned for any service benefits such as increment, higher grade, accrual of leave, promotion and pay revision effective from a date after the date of superannuation.

(ii) The teaching staff of educational institutions who are allowed to continue in service beyond the date of superannuation till the end of the academic year will not be eligible for any leave other than casual leave during the period of their service beyond the date of superannuation and if they apply for any leave other than casual leave during the period, they shall be retired from service from the date of such application of leave.
