As per the minutes of Syllabus Revision Committee held on 03.01.2018 at IHRD Head Quarters and resolved to approve the revised draft syllabus (Scheme 2018) along with the revised rules and regulations for the conduct of following IHRD courses, pattern of Question Paper and the scheme for internal evaluation.

- 1. Post Graduate Diploma in Computer Applications (2 Semesters).
- 2. Diploma in Data Entry Techniques & Office Automation (2 Semesters).
- 3. Diploma in Computer Applications (1 Semester).
- 4. Post Graduate Diploma in Embedded System Design (1 Semester).
- 5. Post Diploma in Logistics and Supply Chain Management (2 Semesters).
- 6. Diploma in Logistics and Supply Chain Management (1 Semester).
- 7. Certificate Course in Library and Information Science (1Semester).
- 8. Short term course on Computerized Financial Accounting using Tally.
- 9. Short term course on Computer Hardware and Network Maintenance.

In the above circumstance, it has been decided to approve the above mentioned nine courses as recommended by the committee constituted for the revision of scheme, syllabus and rules of existing and new IHRD courses.

The approved scheme and syllabus will be applicable from January 2018 admission onwards. The revised scheme of syllabus is published in IHRD website (members area) for further action.
