 satisfactory fulfillment of the contract, if so required.
- Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specification will entail cancellations of the order and purchases being made at the officer's expense from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the government reserve also the right to remove the defaulter's name from the list of government suppliers permanently or for a specified number of years
- Samples, duly listed should be forwarded wherever possible under separate cover and the unapproved samples got back as early as possible by the offerers at their own expenses and the government will in no case be liable for any expense on account of the value of the samples or their transport charges etc. In case, the samples are sent by railway the railway receipt should be sent separately and not along with the quotation since the quotation will be opened only on the appointed day demurrage will have to be paid if the railway parcels are not cleared in time.
